Product description

"A-0 Window 1200 x 2200"

composed of steel frame, incorporating a glass unit consisting of glass construction: 6 mm thick toughened glass ISO 614 (manufactured by Vetrotech saint-Gobain) + 4 mm thick fire layer + 6 mm thick toughened glass ISO 614 + 8 mm air space with steel distance profile + 10 mm thick toughened pressure glass ISO 614.

Total window thickness is 34mm.

The glass pane is supported by two Monolux supporting blocks 35 x 13 x 50 mm and is sealed with silicone rubber gasket Shore 50, 33/40A around the all four edges of glass pane.

Steel frame is fastened to the bulkhead using M6 x12 mm screws at c/c 73 mm.

For further details, see the drawings listed under Type Examination documentation below.

Application/Limitation

The window is approved for installation in steel bulkheads of class A-0. Other applications are subject to case-by-case approval. Bulkhead surrounding the window to be insulated to A-60.

Maximum size of exposed fire technical glazing unit: 1220 mm x 2220 mm (W x H)
Maximum clear light size: 1200 mm x 2200 mm (W x H)

Restricted application: Fire against 6 mm thick toughened glass (internal side).

The window has only been evaluated with respect to fire technical properties (e.g. strength requirements have not been considered). Arrangement and location of any window is subject to approval from relevant authorities in each case.

Each product is to be supplied with its manual for installation, use and maintenance.
